In respect of the Annual and Special Meeting of Shareholders of Ivanplats Limited (the "Company") held May 7, 2013 (the "Meeting"), the following sets forth a brief description of each matter which was voted upon at the Meeting and the outcome of the vote:

Resolution #1

The number of directors was set at eleven for the ensuing year.

Resolution #2

The eleven nominees set forth in the Company's Management Proxy Circular dated April 1, 2013 were elected as directors to hold office for the ensuing year or until their successors are elected or appointed, by resolution passed by a majority of the votes cast on a show of hands vote on the resolution.
